[Both referred jointly as parties and singular as parties]

Whereas "NATIONAL YOUNG ENTREPRENEURS DEVELOPMENT CENTER" (NYEDC) is empowered and authorized training center for various Entrepreneurs Development Program and implements the same by way of having training center across India.

And whereas SHIKSHAN PRASARAK MANDAL'S SAHEBRAO SHANKARRAO DHAMDHERE ARTS & COMMERCE COLLEGE, Talegaon Dhamdhere, Tal- Shirur, Dist.-

Pune. (Skill Enhancement & Entrepreneur Development Cell of the College) intends to enter into a strategic MOU with "NATIONAL YOUNG ENTREPRENEURS DEVELOPMENT CENTER" (NYEDC) in providing certified Entrepreneurs Development training program for its students (preferably final year students of All branches) for various programs in Entrepreneurs Development as may be designed and approved NATIONAL YOUNG ENTREPRENEURS DEVELOPMENT CENTER from time to time.

#### It is hereby agreed as under:

- Both the parties should chalk out plans for action in order to list down the training center to be opened AP's premises.
- 2. AP shall be responsible to as and when requested by NYEDC for marketing through various media for the pre-approved programs within its institute, and marketing the student aware of the benefit that can be derived from these programs. AP shall conduct seminar and allow opportunity to designate during all college event free of cost to propagate and popularize the program within the student.
- AP shall provide space and infrastructure in its premises for opening center & conducting the training program,
- 4. NYEDC shall be responsible to extending the following support:
  - Provide necessary resource person, study material for the training purpose to student.
  - Give the technical, financial, managerial guidance/ consultancy to student.
  - Designing of syllabus, course material.
  - Provide courseware and Certificate to all register students during the training program period.
  - Preparation of practical assignments, project report and question paper for examination.
  - Provide all types support to trained candidates for establishing their small scale industrial (SSI) Unit.
- 5. AP shall be responsible for the following Administrative and marketing support:
  - AP should arrange this EDP & Skill Development program every year for their pre-& final year student.
  - Collect fees from student in the name of NYEDC.
  - Provide adequate infrastructure and facilities inclusive seminar hall, projector, mike system
    etc. in its training center under this MOU in order to efficiently organize the training facility to
    the student.
  - Market and promote the training of the courses designed specifically under this MOU.
- The agreement shall remain valid for three year from date of sighing and shall automatically renewable after that by mutual consent.
- This agreement can be further extended to add more product and technologies by suitable amendment to this agreement.
- 8. This agreement may be terminated by either party with or without any reasons and at its sole discretion by giving the other a clear notice of three months.
- In case of termination of the agreement for any reason, AP shall stop forthwith using the name, trade name of NYEDC from its advertisements, correspondence or any other publicity material.

10. Any disputes between NYEDC and AP shall in the first place be settled by mutual negotiations between the head of the organization or their deputed representatives and their decisions shall be final and binding on both the parties.
