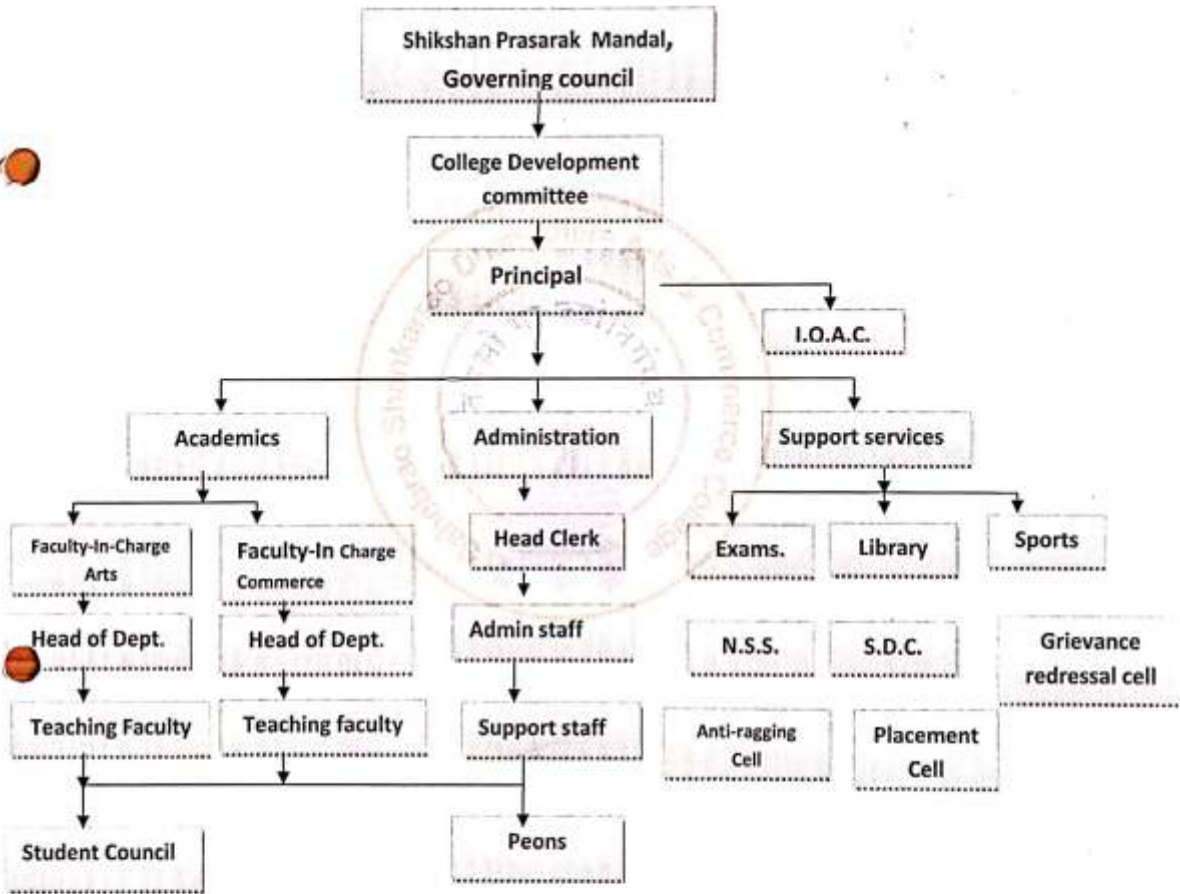

INTRODUCTION

This handbook of code of conduct indicates the standard procedures and practices of the Sahebrao Shankarrao Dhamdhere Arts & Commerce College, Talegaon Dhamdhere, for all the students, teaching and non-technic staff and all the stakeholders. All the stakeholders must know that it is incumbent upon them to abide by this code of professional ethics and conduct and the rights, responsibilities including the restriction flowing from it. All the concerned stakeholders are expected to maintain the highest ethical standards in all organization and activities with others on behalf of the college. The purpose of this code of conduct is to provide guidance to students, teaching and non teaching and stakeholders of the college in performing their duties as responsible citizens. All the concerned stakeholders are required to observe the fundamental principles weather set out for the stakeholders specifically or as expectations set by the college for the conduct of its affairs.

PREAMBLE

The code of conduct and professional ethics is a document that guides the stakeholders of any institute. The Higher education institutes are governed by constituent bodies such as the University, the state and central government and the U.G.C. The smooth functioning of any Higher Education Institute rests upon the strict observance of the guidelines, policies, rules and regulations issued time to time by the authorities. The document consisting code of conduct and Professional Ethics is useful for all concerned stakeholders. The present document intends to provide single point reference for all concerned.

THE COLLEGE DEVELOPMENT COMMITTEE

The college development committee shall -

- (a) Prepare an overall comprehensive development plan of the college regarding academic, administrative and infrastructural growth, and enable college to foster excellence in curricular, co-curricular and extra-curricular activities;
- (b) Decide about the overall teaching programmes or annual calendar of the college.
- (c) Recommend to the management about introducing new academic courses and the creation of additional teaching and administrative posts;
- (d) Take review of the self-financing courses in the college, if any, and make recommendations for their improvement;
- (e) Make specific recommendations to the management to encourage and strengthen research culture, consultancy and extension activities in the college;
- (f) Make specific recommendations to the management to foster academic collaborations to strengthen teaching and research;
- (g) Make specific recommendations to the management to encourage the use of information and communication technology in teaching and learning process;
- (h) Make specific recommendations regarding the improvement in teaching and suitable training programmes for the employees of the college;
- (i) Prepare the annual financial estimates (budget) and financial statements of the college or institution and recommend the same to the management for approval;
- (j) Formulate proposals of new expenditure not provided for in the annual financial estimates (budget);
- (k) Make recommendations regarding the students' and employees' welfare activities in the college or institution;
- (l) Discuss the reports of the Internal Quality Assurance Committee and make suitable recommendations;
- (m) Frame suitable admissions procedure for different programmes by following the statutory norms;

- (n) Plan major annual events in the college, such as annual day, sports events, cultural events, etc.;
- (o) Recommend the administration about appropriate steps to be taken regarding the discipline, safety and security issues of the college or institution;
- (p) Consider and make appropriate recommendations on inspection reports, local inquiry reports, audit report, report of National Assessment and Accreditation Council, etc.;
- (q) Recommend the distribution of different prizes, medals and awards to the students.
- (r) Prepare the annual report on the work done by committee for the year ending on the 30th June and submit the same to the management of such college and the university;
- (s) Perform such other duties and exercise such other powers as may be entrusted by the management and the university.

PRINCIPAL

College Principal should:

- a) Provide inspirational and motivational value-based academic and executive leadership to the college through policy formation, operational management, organization of human resources and concern for environment and sustainability;
- b) Conduct himself/herself with transparency, fairness, honesty, highest degree of ethics and decision making that is in the best interest of the college;
- c) Act as steward of the college's assets in managing the resources responsibility, optimally, effectively and efficiently for providing a conducive working and learning environment;
- d) Promote the collaborative, shared and consultative work culture in the college, paving way for innovative thinking and ideas;
- e) Endeavour to promote a work culture and ethics that brings about quality, professionalism, satisfaction and service to the nation and society;
- f) Adhere to a responsible pattern of conduct and demeanour expected of them by the community;
- g) Manage their private affairs in a manner consistent with the dignity of the profession;
- h) Discourage and not indulge in plagiarism and other non-ethical behaviour in teaching and research;
- i) Participate in extension, co-curricular and extra-curricular activities, including the community service;
- j) Refrain from allowing consideration of caste, creed, religion, race, gender or sex in their professional Endeavour.

TEACHERS AND THEIR RESPONSIBILITIES:

Whoever adopts teaching as a profession assumes the obligation to conduct himself / herself in accordance with the ideal of the profession. A teacher is constantly under the scrutiny of his students and the society at large. Therefore, every teacher should see that there is no incompatibility between his precepts and practice. The national ideals of education which has already been set forth and which he/she should seek to inculcate among students must be his/her own ideals. The profession further requires that the teachers should be calm, patient and communicative by temperament and amiable in disposition.

Teachers should:

- (i) Adhere to a responsible pattern of conduct and demeanour expected of them by the community;
- (ii) Manage their private affairs in a manner consistent with the dignity of the profession;
- (iii) Seek to make professional growth continuous through study and research;
- (iv) Express free and frank opinion by participation at professional meetings, seminars, conferences etc. towards the contribution of knowledge;
- (v) Maintain active membership of professional organizations and strive to improve education and profession through them;
- (vi) Perform their duties in the form of teaching, tutorial, practical, seminar and research work conscientiously and with dedication;
- (vii) Co-operate and assist in carrying out functions relating to the educational responsibilities of the college and the university such as: assisting in appraising applications for admission, advising and counselling students as well as assisting the conduct of university and college examinations, including supervision, invigilation and evaluation; and
- (viii) Participate in extension, co-curricular and extra-curricular activities including community service.

I. TEACHERS AND THE STUDENTS

Teachers should:

- (i) Respect the right and dignity of the student in expressing his/her opinion;
- (ii) Deal justly and impartially with students regardless of their religion, caste, political, economic, social and physical characteristics;
- (iii) Recognize the difference in aptitude and capabilities among students and strive to meet their individual needs;
- (iv) Encourage students to improve their attainments, develop their personalities and at the same time contribute to community welfare;
- (v) Inculcate among students' scientific outlook and respect for physical labour and ideals of democracy, patriotism and peace;
- (vi) Be affectionate to the students and not behave in a vindictive manner towards any of them for any reason;
- (vii) Pay attention to only the attainment of the student in the assessment of merit;
- (viii) Make themselves available to the students even beyond their class hours and help and guide students without any remuneration or reward;
- (ix) Aid students to develop an understanding of our national heritage and national goals.
- (x) Refrain from inciting students against other students, colleagues or administration.

II. TEACHERS AND COLLEAGUES

Teachers should:

- (i) Treat other members of the profession in the same manner as they themselves wish to be treated;
- (ii) Speak respectfully of other teachers and render assistance for professional betterment;
- (iii) Refrain from lodging unsubstantiated allegations against colleagues to higher authorities;
- (iv) Refrain from allowing considerations of caste, creed, religion, race or sex in their professional endeavour.

III. TEACHERS AND AUTHORITIES:

Teachers should:

- (i) Discharge their professional responsibilities according to the existing rules and adhere to procedures and methods consistent with their profession in initiating steps through their own institutional bodies and/or professional organizations for change of any such rule detrimental to the professional interest;
- (ii) Refrain from undertaking any other employment and commitment including private tuitions and coaching classes which are likely to interfere with their professional responsibilities;

- (iii) Co-operate in the formulation of policies of the institution by accepting various offices and discharge responsibilities which such offices may demand;
- (iv) Co-operate through their organizations in the formulation of policies of the other institutions and accept offices;
- (v) Co-operate with the authorities for the betterment of the institutions keeping in view the interest and in conformity with dignity of the profession;
- (vi) Should adhere to the conditions of contract;
- (vii) Give and expect due notice before a change of position is made; and
- (viii) Refrain from availing themselves of leave except on unavoidable grounds and as far as practicable with prior intimation, keeping in view their particular responsibility for completion of academic schedule.

IV. TEACHERS AND NON-TEACHING STAFF:

- (i) Teachers should treat the non-teaching staff as colleagues and equal partners in a cooperative undertaking, within every educational institution; and
- (ii) Teachers should help in the function of joint staff-councils covering both teachers and the non-teaching staff.

V. TEACHERS AND GUARDIANS

Teachers should:

- (i) Try to see through teachers' bodies and organizations, that institutions maintain contact with the guardians, their students, send reports of their performance to the guardians whenever necessary and meet the guardians in meetings convened for the purpose for mutual exchange of ideas and for the benefit of the institution.

VI. TEACHERS AND SOCIETY

Teachers should:

- (i) Recognize that education is a public service and strive to keep the public informed of the educational programmes which are being provided;
- (ii) Work to improve education in the community and strengthen the community's moral and intellectual life;
- (iii) Be aware of social problems and take part in such activities as would be conducive to the progress of society and hence the country as a whole;
- (iv) Perform the duties of citizenship, participate in community activities and shoulder responsibilities of public offices;

(v) Refrain from taking part in or subscribing to or assisting in any way activities which tend to promote feeling of hatred or enmity among different communities, religions or linguistic groups but actively work for National Integration.

EMPLOYEES (ADMIN & TEACHING STAFF)

1. Employees must serve towards vision and mission of the college.
2. They must perform their daily activities as assignment by the authorities as prime responsibility for the betterment of the college and society.
3. They must have positive relationship with students, colleagues and parents and society.
4. Every employee shall abide by and comply with the rules and regulations of the college and all orders and directions of his/her superior authorities, under whose superintendence or control, he/she is placed.
6. Every employee shall seek to promote the interests of the College and shall not act in any manner prejudicial thereto.
7. No employee shall join, or continue to be a member of an association that is designated as anti-national or that disturbs social harmony in any manner.
8. No employee shall engage directly or indirectly in any trade or business or undertake any other employment. For undertaking honorary work of a social and charitable nature or work of a literary, artistic or scientific character the employee shall obtain prior permission of the authority.
9. Obligation to maintain secrecy: Every employee shall maintain the strictest secrecy regarding the activities of the college. No employee should leak directly or indirectly, any information that is confidential nature
12. Employee should come in the office in time and should be in office dress code.
13. Avoid using cell phone in the office/ internet for personal use.
14. Employees are strictly prohibited to smoke, consume drugs, tobacco and gutkha.

STUDENTS

1. While on campus, students should not use mobile phone to listen to music, to record someone else's conversation or a video. Students should not use mobile phone for making or receiving voice call or messaging during the lecture, lab work, in the library, during any curricular, co-curricular or extra-curricular activity. If any student is found breaching any of the above rule his/her mobile phone will be seized and will be charged fine of Rs. 500/- The mobile will be returned only after parent of the concerned students

visit personally and sign a written explanation. Further breach of the college rule can cause the cancellation of student's admission.

2. Students are not allowed to bring costly jewellery or articles in the college campus. The college bears no responsibility if any personal property of the student is lost in the college campus.
3. The students should park their vehicles in the Parking slot designated for students. Parking or driving the vehicle except the parking area will cause the disciplinary action against the concerned student. As responsible citizens, it is our duty to safeguard our environment. Therefore, students will not cause noise pollution on the campus by not using powered vehicles or unnecessarily blowing horns.
4. Minimum 75% attendance in the classes is obligatory for students. Students with lower attendance will not be allowed to fill up exam. Form. If a student cannot attend classes due to medical or any other reason, he/she should give an application to the class mentor.
5. The medical check up is compulsory for First year students.
6. While on campus, students shall, at all times wear their I-Cards well displayed. They should be able to produce it before any teaching /administrative staff as and when required.
7. If any harm is caused to college property in the campus, in the classrooms, computer labs, library etc., the disciplinary action against concerned student/students will be taken by the college.
8. Students shall maintain silence in the academic building. Speaking loudly, hooting, whistling, loitering or making catcalls will be treated as a violation of campus discipline.
9. Students are advised to participate in all academic, extension, curricular and extra-curricular activities and use all such facilities available optimally in order to become competent and efficient mentally and physically.
10. Any information related to the college/Trust shall not be given to media or be displayed on notice boards or else where without prior permission of the competent authority.
11. Disciplinary action will be taken against student/s indulging in malpractices during examination. Any such student/s will not be given admission to the next academic year.
12. Misbehaviour of any sort with the college staff/teachers/fellow students will be treated liable for disciplinary action to the extent of termination of admission.
13. Consumption of alcohol, chewing tobacco or smoking is strictly prohibited on the college campus.
14. No student shall indulge in any kind of anti-social, anti- institutional or any sort of

immoral or un-ethical activities on the college campus. Anyone found guilty will be liable to disciplinary action.

15. The College Development committee will be formed as per the University guidelines.
16. Any form of harassment such as ragging, eve-teasing or obscene behaviour with fellow students or staff is highly objectionable and is liable to be treated as a criminal offence.
17. In case of admission cancellation, the fees will be deducted as per the University rules.
18. Any candidate with criminal record is not eligible for admission in the college.
